Selection Process

Scholarship recipients are selected during the spring semester. All scholarships are awarded for the following academic year and are renewable yearly if students meet the respective minimum requirements for their scholarship. All applicants, including scholarship winners, will be notified in writing by regular mail.

Eligibility	<ul style="list-style-type: none"> • Students entering Form 9 • Students with a minimum GPA of 3.2 in core academic classes (English, math, science, and social studies) for grades six (6) through eight (8) • Students who score an average in the 85th percentile or above in the four sections of the Independent School Entrance Examination (ISEE) with no individual score below the 75th percentile in any one section • Students must have participated in at least one school-approved extracurricular activity each year during grades six (6) through eight (8)
