

**RELEASE AND HOLD HARMLESS AGREEMENT
OAK VALLEY STABLES

For 17 years of age or under. See separate form for adults.

I, (print parent's name) _____, consent to allow my child (print child's full name) _____ date of birth _____, to voluntarily participate in various activities, to include horseback riding at Oak Valley Stables. I am fully aware and understand that there is some risk of death or personal injury to my child and damage to or loss of his/her personal property which may occur as a result of his/her participation.

In consideration for my child being allowed to participate in the various activities of the Oak Valley Stables. I for myself, my child, and his/her heirs, administrators, executors, and assignees, make the following agreement:

1. The Oak Valley Stables and any agency, entity, instrumentality, and employee thereof, shall not be liable to me or my child for any personal injuries or death or damage to personal property caused by defects, disrepair, or faulty construction of the Oak Valley Stables premises. The Oak Valley Stables, as used herein, includes any officer, agency, volunteer, or employee of the Oak Valley Stables, whether acting officially or otherwise.

2. I hereby agree, from this day forward and until the end of time, to indemnify, release, and hold harmless the Oak Valley Stables, and any agency, entity, instrumentality, and employee thereof from and against any and all claims or causes of action for damages to property or death or personal injury incident to or arising from my child's use of the Oak Valley Stables premises, or from any activity, work or thing done, permitted, or suffered by my child in or about the Oak Valley Stables premises.

3. The Oak Valley Stables shall not be liable to me or my child for personal injuries or death or property damage or loss from theft, vandalism, fire, flood, water leaks, hurricane, rain, hail, ice, snow, lightning, wind, explosion, accident, or other causes whatsoever, regardless of whether such injuries, death, or damages are caused in whole or in part by the negligence of the Oak Valley Stables or any agency, entity, instrumentality, volunteer, or employee thereof.

4. IT IS MY EXPRESS INTENTION THAT THE INDEMNITY PROVIDED FOR IN THIS AGREEMENT IS INDEMNITY BY ME ON BEHALF OF MYSELF AND MY CHILD TO INDEMNIFY AND PROTECT THE OAK VALLEY STABLES FROM THE CONSEQUENCES OF IT'S OWN NEGLIGENCE WHETHER THAT NEGLIGENCE IS THE SOLE OR CONCURRING CAUSE OF THE INJURY, DEATH, OR DAMAGE.

5. I agree that I will never prosecute or in any way aid in prosecuting any demand, claim or suit against the Oak Valley Stables for any loss, damage, injury to person or property, or death that may occur from any cause whatsoever as a result of my child taking part in the activities of the Oak Valley Stables.

6. I understand and agree that I AM ASSUMING THE RISK on my child's behalf of any personal injury or property damage that may result from my child taking part in the Oak Valley Stables activities. This includes such injuries or damage as may be caused by the negligence of the Oak Valley Stables.

7. I understand and agree that I will be liable for any damage or loss to the Oak Valley Stables which is caused by my child's gross negligence, willful misconduct, or fraud.
